## INFORMATION

Dear friends,

This is in continuation of the Federation's previous letter dated 17-03-2023, I again request the Presidents/General Secretaries of all States/Union Territory and Central Government Driver Associations to authorize five executive members from their respective states for the elections to be held on March 25, 2023 along with their departmental identity cards and mobile numbers along with last three years' outstanding membership fee of Rs.6300/- (Rs.2100/- per year) which may be deposited online ([www.aigdf.org](http://www.aigdf.org)) in Federation's bank account and submit the receipt to the Federation office latest by 2.00 PM on March 24, 2023. It is informed that on the request of the Federation, Govt. of NCT of Delhi has appointed Shri Ravi Prakash, Superintendent as the Returning Officer and Shri Sandeep Sharma, Senior Assistant to assist the Returning Officer for the Election to be held on 25<sup>th</sup> March, 2023.

It was decided in the meeting held with the Returning Officer to hand over all the documents related to election along with Voter List to the Returning Officer in the evening of 24<sup>th</sup> March, 2023 so that the election process may be started in time on 25<sup>th</sup> March, 2023.

I request all my friends to co-operate in conducting the Federation elections as per the rules. It is also clarified list of authorized representatives of all the States / UTs/Central Government Drivers Associations along with Membership Fee is not received by 2.00 PM on March 24, March 2023, will not be included in the voter list and they shall not be eligible to participate in the election process i.e. for voting and contesting in the elections, for which the State Driver's Associations itself will be responsible. Complete arrangements are being made to maintain law and order for peaceful conduct of elections. The voter list will be finalized on 24.03.2023 on the basis of particulars as mentioned above are received by 2.00 PM of 24/03/2023 and shall be handed over to the Returning officer for free, fair and smooth elections.

The Presidents/General Secretaries of all the state drivers' associations/committees are once again requested to cooperate in order to conduct the elections of the federation in a peaceful manner as per the rules and forward the list of five authorized members to participate in the election process along with Membership fee before 2.00 PM on 24/03/2023 for fair and peaceful.
