Subject: - Warning of national movement if pending demands and problems of Government drivers of India are not resolved.

Hon'ble Sir,

All India Government Driver Federation has written more than 40 letters during last several years regarding its problems and demands of Government Drivers, but our demands and problems have not been resolved yet. With the objective of wiping the tears of the drivers, a meeting was held in 2020 with Dr. Jitendra Singh, Hon'ble Minister of State, Prime Minister's Office and Ministry of Personnel, Public Grievances and Pensions, Government of India in his office in North Block, but this meeting did not yield any result. The driver class is writing this letter again with a very sad heart due to the silence of the Government of India that a decision should be taken soon on the reasonable demands of the drivers. The honourable minister informed that some of your demands are related to the Finance Ministry and Transport Ministry, which will be sent to the concerned ministries and departments for appropriate action and a meeting with them will also be fixed but no action has been taken till now.

The demands of the drivers are as follows:-

- 1. The post of government drivers should be declared as a technical post.
- 2. Drivers in India should be given "one work one pay scale".
- 3. Recruitment should be done on the vacant posts of drivers in the government without delay and drivers appointed on contractual basis should be regularized.
- 4. Drivers should be represented in the Government Consultative Machinery (JCM).
- Government vehicles should be insured.

- 6. Ratio should be removed from the Staff Car Driver Promotion Scheme.
- 7. Trade test should be removed from the Staff Car Driver Promotion Scheme and exemption should be given from trade test at the time of renewal of license.
- 8. The driver recruitment rules should be amended so that drivers can get the benefit of promotion to other technical posts as well.
- 9. New government vehicles should be purchased against the condemned government vehicles.
- 10. Misuse of government vehicles should be stopped.
- 11. Running of private vehicles as taxis should be stopped.
- 12. Office space or plot should be allotted to the for Federation in Delhi for its office.
- 13. In case of death of a driver, his dependent should be given job on compassionate grounds.
- 14. The initial minimum salary of drivers should be fixed in Pay-Matrix-5 because the driver takes road risk along with technical work.

Honourable Sir, All India Government Driver Federation requests you to organize a meeting with the officials of Ministry of Personnel, Public Grievances and Pension, Department of Personnel and Training, Government of India, Ministry of Transport, Ministry of Finance to reconsider its the demands of the Federation so that immediate action can be taken on the burning demands of the drivers, otherwise the government drivers will be forced to go for a nationwide movement.

The Federation and the government drivers of India will be grateful to you.
