You should also clarify whether this organization is registered or not and if yes, where is it registered and if not, why are you supporting any unconstitutional organization. What its rules and bye-laws have been made, to make the said confederation and what is the preamble of that unconstitutional organization, you must explain whether you want to be a member of the Legislative Executive or any unconstitutional organization.
